In 2022, you will begin the recertification process. One of the performance criteria for recertification is Continuing Education. The Board requires that all Diplomates maintain a record of continuing education activities to ensure a complete and accurate evaluation of these activities. Activities must be recorded in the ABT online tracking system. Please be sure to download the Recertification Handbook from the ABT website.
